Moneythink aims to service each classroom with a mentor-to-student ratio of 5-to-1 or less. While Moneythink often works with high schools, programs can also be held in community centers, youth centers, homeless shelters, public libraries, and any other venue where high school students congregate. In 2013-2014, Moneythink taught a year-long program (24 weeks) during which volunteers go into at-risk communities and teach financial capability across four areas: spending money mindfully, saving money, using financial products safely, and earning money.
